# 1. Apologies

Previously used contractor Steve Anton's quotes are awaited, including a daily rate for Mockbeggar Lane East ditch and sumps.

Following the meeting with Natural England, brambles were requested to be removed under the existing consent with an extension until 31 March (ensuring bushes are inspected first for nests). It was proposed for the clerk to request Tom Hordle to carry out the work again, up to an amount of £300. Seconded, all in favour (8).
